BURIAL GROUNDS

The fee payments and sums set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before his death was, an inhabitant or parishioner of the District of Corby, or, in the case of a stillborn child, where the parents (or one of them) are, or at the time of the interment were, such inhabitants or parishioners.

In all other cases, the fees, payments and sums will be doubled, except that those set out in parts I and IV will not be doubled where the exclusive right of burial in the grave in question, or the right of constructing the grave or vault, was acquired at the single fee as set out in Part II or III.
